2016 Reorganization Meeting January 12, 2016

Schultzville, NY

The Town of Clinton Reorganization Meeting was held on this day in the Town Hall. Present were Supervisor Ray Oberly and Councilpersons Claudia Cooley, Eliot Werner, and Dean Michael. Town Clerk Carol-Jean Mackin was also present. Councilman Appolonia was absent. There were four people the audience.

At 6:00 PM Supervisor Oberly called the meeting to order and led the Pledge of Allegiance.

SUPERVISOR'S COMMENTS

2015 was a very busy year to make the needed improvements to the Town's facilities and procedures. These were the three major safety improvements made; replaced the concrete top deck of the Library's stairs and replacing the two emergency porches for the Court area. The much needed replacement of the two entrance doors to the main highway garage was done. The new propane heaters for the highway office and break room were installed and became operational to replace the worn out highway fuel oil heater. A new 10 wheel combination dump/snow plow truck was purchased using CHIP's funds and received. The Highway Department participated in the Dutchess County Shared Services Grant with other adjacent Towns for the purchase and use of a mini excavator and bucket truck which should be received later this year. The Town's computers were all replaced and upgraded from OS XP to OS System 7. The Town enacted a Solar and Wind Zoning Law amendment. There was a significant last minute increase of 18% in the Highway crew's MVP medical insurance so another plan had to be negotiated to provide the coverage starting on January 1, 2016. Another big effort was to change our banking from Chase Bank to M&T Bank since Chase was going to charge us \$1,400 monthly to service our accounts. The changeover is almost done. A TAN (Tax Anticipation Note) for \$250,000 was obtained for 2016 to allow the Town to pay its bills in January, February, and March until the property tax monies come in. The Town submitted a Community Development Block Grant for the improvement of the Frances J. Mark Memorial Recreation Park to improve handicapped facilities and to build a new basketball court there.

The other major effort during the year was the opposition to NYS PSC proposed AC Transmission Line to provide New York City with electricity from western New York. The December 17, 2015 PSC decision was to build a new line to replace the existing 115 KV with a monopole with a 115 and a 345 KV line on it. We joined Hudson Valley Smart Energy Coalition (HVSEC) and stopped the taking of a strip of land 165 feet wide by eminent domain alongside one of the existing powerlines. We also stopped the significant increase in tower/monopole heights above the existing tower heights of 80 feet. The next step will be to have the NYS Independent Service Operators (NYS ISO) do a new RFP from developers then come back to PSC to start up the Article 7 siting process again. We expect construction to probably start in 2020.
