# **OLD BUSINESS**

# 1. Approve resolution adopting local law to amend the Solar law

Dean said miscommunication between attorney and the planner during the creating of the solar law, and so certain wording was taken out and now people need building permits for items that were never necessary, including sheds and certain accessory stuctures. This law corrects that. Mr. Michael said that this resolution is to reinstitute the section that was taken out when the law was amended.

MM Councilman Michael, 2nd Councilwoman Cunningham to approve the following resolution: BE IT RESOLVED that the Town Board approves **Resolution No. 28** of 2016 adopting local law 1 of 2016 entitled, "Amendment to Section 250-22 of the Town Code, Accessory Structures. All aye. Motion carried.

# 2. Approve local law to amend section 250 of the Town Code to authorize prosecutorial powers to certain employees

This was not defined properly in the Town Code. This local law corrects that.

MM Supervisor Oberly, 2nd Councilman Michael to approve the following resolution: BE IT RESOLVED that the Town Board approves **Resolution No. 29 of 2016 approving local law number 2 of 2016 entitled, "Prosecution of Town Code Violations"** All aye. Motion carried.

# 3. Approve resolution authorizing the acceptance of a new surety for the completion of certain construction at the crimson hill subdivison and the release of the existing irrevocable letter of credit

MM Supervisor Oberly, 2nd Councilwoman Ms. Cunningham to approve the following resolution: BE IT RESOLVED that the Town Board **approves Resolution No. 30 of 2016 approving the surety bond for the completion of Crimson Hill subdivision.** All aye. Motion carried.

# 4. Update CDBG

Nancy Cunningham said that this matter was already discussed when she gave her report regarding the Rec Committee. The bids need to be back by August 9, 2016.

# 5. Update on Taxpayer grant

Ray Oberly talked about the grantthat allows us to get money from the county. This way when the power goes off, this will help the town with the power (generator) and the money left will use for solar panel to help us reduced the cost of electric. Nancy said that in theory this will help the cost of electric and help reduced the cost of the taxes. Dean said that it will actually reduce the budget.

# 6. Discuss requesting a forum held by Sue Serino to discuss Resolution 7 of 2016 to reform the NY State public education funding

Mike Appolonia said that there are 12 states that still do that, the city of NY doesn't fund school through property taxes not for many years. He also indicated his meeting with Sue Serino's office and he's proposing that Sue will come to the Town to give us forum to let us know what is happening. Sue is looking into it so that the burden is not to the property owners.

Ray said that Sue can come here at any time but noted that the town doesn't participate in any of the school funding. We are not sponsoring, she is welcome to come here and the town will host it.

Dean agreed. Mike said that this will be Sue Serino's forum, the town will only providing the venue.

Mike indicated his concern about the outrageous increase in the amount of school taxes since he moves up here. Something has to get done.

The board agreed that Sue can come to the Town. No action taken.

# NEW BUSINESS

## 1. Approve Russ Tompkins to attend State Magistrates conference

MM Supervisor Oberly, 2nd Councilman Nancy to approve Russ Tompkins attendance at the NYS Magistrate's Conference and Training Sept. 25 through Sept. 28 at Lake Placid, NY at a cost not to exceed \$738.00. All aye. Motion carries.

Dean said that this is when Judge Seelbach goes back to NYC. Ray said that this is basically just for the hotel expenses.

## 2. Discussion on speed control on Salt Point Turnpike

Councilman Werner discussion:

Mr. Werner indicated the growing traffic in the town due to increasing number of AirBnB. The concern is speed limit. He said that the something needs to get done about the speed on Salt Point Turnpike. It is the DOT that restrict the limit according to Dean. The Dept of Transportation does the speed study, they review it and decide whether it's necessary to reduce the speed. Eliot cited the instance that happened years ago in Bulls Head Road about the applicant for the subdivision process. The County reduced the limit due to that concern. Dean said that this is a state issue and part County. Ray said that state is the one who really has the purview on this. Eliot asked how to pursue this. Ray said you fill out the form, and suggest what the speed limit and the State will review it. The town sends this form. Dean said that the cost is for the Town to bear. Eliot expressed his eagerness to pursue this – this is a hamlet, people should not speed up on this road, the speed here is 40 and people will drive 55 miles. The board discussed about reducing the speed on the areas where drivers are driving awfully beyond the speed limit. The town needs to do something to alleviate this issue. Eliot expressed his concern about this and wants to pursue this issue. Eliot will do some work on how to pursue this mater. - No action taken.

Idan Sinms of PumpkinLane spoke and indicated the July 13, monthly meeting of the East Clinton fire District. He encouraged the homeowners to attend this meeting. \$22 million dollar Fire House is being proposed by East Clinton Fire District. He also questioned the need of two fire district in the Town of Clinton. The population is only 4,000; feels that the fire district (east and west) in the Town should be combined. We are a small community. We do not need 2 firehouses. He suggested to have a special advisory committee and can have one board member from the Town Board and rest are are from town residents. He suggested that there can be two meetings in a month, first meeting is for the committee and second one is open to public discussion.

RayOberly indicated the areas of coverage of East Clinton Fire District.

MM Supervisor Oberly, 2nd Councilman Michael to return to the regular order of business. All aye. Motion carried.
