## Town of Clinton Conservation Advisory Council Minutes – June 10, 2015

The meeting was called to order at 7:05 PM by Norene Coller, Chair.

Members present: Norene Coller, Barbara Mansell and Bill Relyea.

Members of the public present: Dick Coller, Paula Wolf Trimble and Michael Trimble.

**Public Comment**: Paula Wolf Trimble made a presentation summarizing the research done by Cornell University and the NYS DEC on their land along the upper watershed of the Crum Elbow Creek last year with many methods used to observe and seek evidence of the presence of common and rare mammals, birds, reptiles and amphibians. Stream macroinvertebrates were also surveyed. Connected habitats were observed to be important wildlife locations in the area.

**Minutes:** A motion to approve the minutes of May 13, 2015, was made by Bill Relyea and seconded by Norene Coller. All members voted in favor.

**Communications:** The deconstruction of a dam on the Kliros property on the Little Wappinger Creek in Hibernia was discussed. The Clinton Planning Board will require the applicant to get a steep slope permit for the dam deconstruction. The engineer for Ms Kliros will appear before the Planning Board on June 16<sup>th</sup>.
