## RESOLUTION AUTHORIZING THE TOWN SUPERVISOR TO EXPEND THIRTY-THREE THOUSAND NINE HUNDRED SIXTY-FOUR AND 00/100 DOLLARS (\$33,964.00) FROM TOWN RESERVE ACCOUNT NO. ER 7779.1, SUBJECT TO PERMISSIVE REFERENDUM, FOR THE PURPOSE OF PURCHASING AND ACQUIRING A 2019 FORD F-350 TRUCK WITH DUMP BODY.

**WHEREAS,** the Town Highway Department requires a new vehicle for the proper maintenance of town roadways and town owned property;

**WHEREAS**, the Town Board desires to expend Thirty-Three Thousand Nine Hundred Sixty-Four and 00/100 Dollars (\$33,964.00) from Town Reserve Account No. ER 7779.1 for the purpose of using this sum toward the purchase of a Ford F-350 Truck with dump body (the "vehicle") to meet the needs of the Town Highway Department;

WHEREAS, the probable useful life of the vehicle to be purchased exceeds five years;

**WHEREAS,** General Municipal Law Section 6-c requires a permissive referendum when the probable usefulness of the equipment to be purchased from a town reserve fund exceeds five years;

WHEREAS, the permissive referendum is governed by Article 7 of the Town Law; and

**WHEREAS**, Article 7 of the Town Law requires the Town Clerk within ten days of adoption to post and publish a notice of adoption along with an abstract concisely stating the purpose and effect of the resolution.

## NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

(1) The Town Supervisor is authorized, directed and empowered to purchase and acquire the vehicle by utilizing Thirty-Three Thousand Nine Hundred Sixty-Four and 00/100 Dollars (\$33,964.00) from Town Reserve Account No. ER 7779.1, subject to the Town meeting the permissive referendum requirement; and

(2) The Town Clerk is hereby authorized, empowered and directed to post and publish a notice of adoption of this resolution within ten (10) days hereof along with an abstract concisely stating the purpose and effect of this resolution in accordance with the requirements of Article 7 of the Town Law.

The vote having been taken upon such resolution the result was as follows:
