

Resolution 26 of 2019

Agreement for the Expenditure of Highway Moneys

AGREEMENT between the Town Superintendent of the Town of Clinton,
Dutchess County, New York, and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

1. GENERAL REPAIRS. The sum of \$ 23,000 shall be set aside to be expended for primary work and general repairs upon 10 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or renewals thereof.
2. PERMANENT IMPROVEMENTS. The following sums shall be set aside to be expended for the permanent improvement of Town highways:

(a) On the road commencing at Field RD and leading to Quarfelt Rd, a distance of 0.6 miles, there shall be expended not over the sum of \$ 104,850.00.

(b) On the road commencing at Rynders and leading to Seelbach Lane, a distance of 0.5 miles, there shall be expended not over the sum of \$ 8,600.00.

(c) On the road commencing at Seelbach and leading to Meadowbrook, a distance of 1.1 miles, there shall be expended not over the sum of \$ 17,500.00.

Subbase	<u>Blacktop</u>

(d) On the road commencing at Shadblow and leading to Pumpkin, a distance of 1.2 miles, there shall be expended not over the sum of \$ 17,750.00.
