counsel, in support of said Petition and the owners of record, Norma Herzlin, having appeared by Cuddy & Feder, in opposition to said Petition, and the Court having found to its satisfaction that the procedural requirements of the Eminent Domain Procedure Law have been met, it is hereby

ORDERED, that the Petition is granted, and it is further

ORDERED, that this Order shall be filed together with the acquisition map herein, in the Office of the Clerk of Dutchess County, and upon the filing of the Order and acquisition map, the permanent right-of-way easement and temporary easement(s) for construction purposes shown in said acquisition map and described therein shall be vested in the Petitioner, provided, however, that title to the temporary construction easement(s) will revert to the Respondents or their successors in interest upon the completion of construction activities and the restoration of the right-of-way, and it is further

ORDERED, that Petitioner shall deposit a bond or undertaking in the amount of \$ 5,000⁰⁰ with the clerk of this Court upon the filing of the Order and the acquisition map, this bond or undertaking to be applied in the amount necessary for any default by Petitioner in the payment of all or part of the damages determined in the acquisition proceeding or the abandonment thereof, and it is further

ORDERED, Petitioner shall serve upon Condemnees a notice of this acquisition within thirty (30) days after entry of this Order, pursuant to Eminent Domain Procedure Law Section 502(B), and it is further

ORDERED, that the time for condemnees to file a claim in this proceeding pursuant to Eminent Domain Procedure Law Section 503(B) shall be one (1) year from the date the notice of acquisition is served upon the condemnees by Petitioner.

All that certain lot, piece or parcel of land situate, lying and being in the Town of Clinton, County of Dutchess and State of New York more particularly bounded and described as follows: A strip of land twenty-five (25) feet in width for permanent right-of-way and easement as shown on the accompanying Plat No. COND - NY 53-005, bounded on the north by lands now or formerly of John W. Mangan, et ux, bounded on the east by lands of Niagara Mohawk Power Corporation, bounded on the south by the northerly side of Farm Road, and bounded on the west by a line running across the subject tracts parallel to and thirty (30) feet westerly of the following described survey line:

Beginning at a point in the lands of Niagara Mohawk Power Corporation on an extension of the line common to the northeasterly side of the subject tract and the southwesterly side of the lands now or formerly of John W. Mangan, said point being a distance of 5 ± feet easterly along the extension of said line from the westerly side of the lands now or formerly of Niagara Mohawk Power Corporation; running thence S 15° 27' 00" W 1296.6 feet to the point of exit in an extension of the line common to the southwesterly side of the subject tract and the northerly side of Farm Road, said point of exit being a distance of 5 ± feet easterly along said line from the westerly line of the lands now or formerly of Niagara Mohawk Power Corporation, containing 0.74 acres more or less.

After completion of construction of the pipeline, the temporary work space easements shall revert to the condemnees.

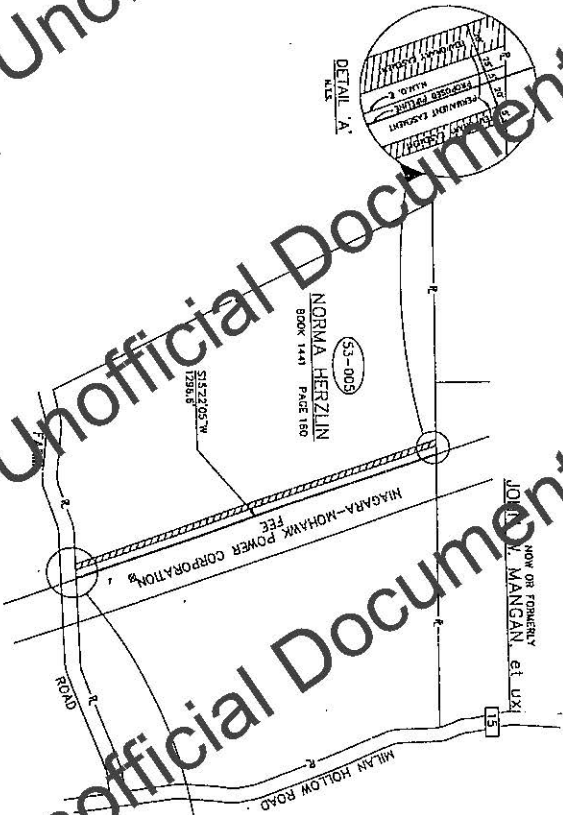
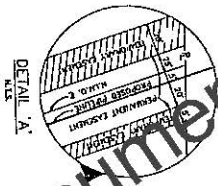
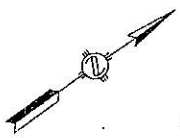
