**Education Outreach** - Lynne

The CAC&CSC will have a table at the Clinton Community Library Book and Plant Sale in May, and at the Clinton Community Day in September. Holding an NRI event in the Town Hall, sharing Composting, and Pollinator events were some more ideas for education outreach. The CCEDC is a good resource to explore.

Joe is particularly interested in these events as they count as points towards Bronze certification for the CSC Task Force.

Deborah researched the cost to print and mail CAC&CSC informational postcards to the community, which was quite expensive. Instead, postcards will be created describing the CAC&CSC to be used as handouts at educational events.

The March issue of “12 Monthly Tips for Being a Friend to the Environment” will be sent via MailChimp to residents. This is a monthly email with information from the DEC website “Living the Green Life”. The email will include a link to the CAC&CSC website.

**Planning Board**

Margaret attended the March 5, 2024, Planning Board meeting. Many of the items before the board were about permits for driveways up steep slopes. The board clearly expected proper design and engineering for their approval. She wondered if the CAC should also receive these items to review.

Katherine shared links to the Climate Resilient Hazard Mitigation Plan that she edited for the county with Joe. Joe has shared the information with Anna Harrod-McGrew of the CCEDC for her review and assessment for Bronze certification qualification.
