The Clinton Town Board held the Regular Town Board meeting on this day in the Town Hall. Present were Deputy Supervisor Werner, Councilman Michael, and Councilwoman Mustello. Town Clerk Carol Mackin was also present. Supervisor Mike Whitton was absent as was Councilman Juliano. There were approximately 10 people in the audience.

Deputy Supervisor Werner called the meeting to order at 6:30 PM and led the Pledge of Allegiance.

The Town is moving ahead with the long-awaited painting of the Masonic Hall. We are awaiting the signed contract to be returned by the vendor. The work is expected to be completed by July 1, weather permitting.

We are also moving ahead on the installation of a new phone system and a new software program for the Building, Zoning, and Highway departments. Both of these projects should be up and running in the next several months.

Our plans to move ahead on possibly joining a new CCA program—which we discussed at the March meeting—are on hold, at least for the time being. Individuals can sign up through Central Hudson if they want a different energy supplier.

And finally, on a personal note, I want to thank the Town employees (particularly Town Clerk Carol Mackin, Deputy Town Clerk Mary Molly and Cathy Gallinger, assistant to the Town supervisor) for their efforts to ensure that the business of the Town goes smoothly. Their work has been extraordinary.

OLD BUSINESS

1. Approve Local law to amend Section 210 of the Town Code (Firemen's Exemption) – Werner

MM Deputy Supervisor Werner, 2nd Councilman Michael that the Town Board approves the following resolution: BE IT RESOLVED that the Town Board approves **Resolution No. 24 of 2023 adopting Local Law No. 3 entitled "Local Law Amending Article VII of Chapter 210 of the Town Code – Property Tax Exemption for Volunteer Firefighters and Ambulance Workers"**, and further the Town Clerk is directed to enter this Local Law in the minutes of this meeting and give due notice its adoption to the Secretary of the State of New York. Dean Michael said that it should be clarified that the property is located in the town of Clinton. All agree to this minor change. Also concerned about the timing of the notice, all agree it is fine as written. All aye except Supervisor Whitton and Councilman Juliano who were absent. Motion carried.

2. Discuss Section 250-51 of the Town Code - Farming - Werner

The town attorney is doing a final review and we will introduce the law next month with a public hearing in June.

3. Discuss Planner for Planning and Zoning – Werner

Deputy Supervisor Werner is reaching out to several Planner candidates; Neil Wilson has retired. Mr. Werner will meet with the two. Dean Michael pointed out we have a contract with the CPL for the services of a Planner and suggests we should wait for the new year. Eliot will pull the CPL contract to review.

OTHER

Dean Michael—regarding the cemetery on Browning Road, Dean gave Eliot a map of the property showing the cemetery and the church which are no longer there. Dean got it from Dutchess County. Eliot will follow up to see if he can contact the owner of the property.

1. Approve Resolution to return unused escrow funds – Werner

MM Deputy Supervisor Werner, 2nd Councilman Michael that the Town Board approves the following resolution: BE IT RESOLVED that the Town Board approves **Resolution No. 25 of 2023 returning unused escrow funds**. 2. Approve Resolution naming two private roads – Werner

MM Deputy Supervisor Werner, 2nd Councilman Michael that the Town Board approves the following resolution: BE IT RESOLVED that the Town Board approves **Resolution No. 26 of 2023 naming two private roads at the request of Dutchess County E-911.** All aye except Supervisor Whitton and Councilman Juliano who were absent. Motion carried.

3. Approve Highway Superintendent Martin's attendance at Highway School – Mustello/Michael

MM Councilman Michael, 2nd Councilman Mustello that the Town Board approves the following resolution: BE IT RESOLVED that the Town Board approves Highway Superintendent Martin's attendance at Highway School, being held at Ithaca College from June 5 – 7 at a cost not to exceed \$650 for the school, meals and lodging. All aye except Supervisor Whitton and Councilman Juliano who were absent. Motion carried.

4. Approve Hudson Valley Hatchett - axe throwing at Community Day - Werner

MM Deputy Supervisor Werner, 2nd Councilman Michael that the Town Board approves the following resolution: BE IT RESOLVED that the Town Board approve Hudson Valley Hatchett as the axe throwing vendor for Community Day at a cost not to exceed \$800 upon the following conditions: receipt of a certificate of insurance, the signed vendor contract, and the posting of Town-approved rules at the booth. All aye except Supervisor Whitton and Councilman Juliano who were absent. Motion carried.
