### **SUPERVISOR'S COMMENTS**

- The Clinton Town Offices, Highway Department, Justice Court Office, and Court will be closed for the Juneteenth holiday on Monday, June 20 and the Independence Day Holiday on Monday July 4th. The Clinton Community Library will also be closed on both of those days.
- The East Clinton Volunteer Fire Department is conducting a Smoke Detector Giveaway. There is a limit of one free smoke detector per household. You can receive yours by emailing clintonvolunteerFD@gmail.com or calling 845-204-9013. A special thanks to Williams Lumber for helping facilitate this giveaway.

- The United States Postal Service is offering another round of free covid test kits. You will receive 8 tests in this round. To order your free test kits, visit usps.com/covidtests.
- Last month I reported that Columbia Utilities, the third-party electricity supplier for the Town's Community Choice Aggregation program, was seeking to terminate the agreement, citing the billing issues with Central Hudson. In the past month, the Town of Clinton, along with the 13 other cities, towns, and villages in the program have joined a lawsuit seeking an injunction against Columbia Utilities. This lawsuit is being handled by attorneys for Joule Power at no cost to our taxpayers. In the last week, the Public Service Commission filed a motion in support of our motion for a Preliminary Injunction. The Court granted our Order to Show Cause for a Temporary Restraining Order. This was good news for our residents. Yesterday, Columbia requested that the restraining order remain in place until at least August to give the parties an opportunity to discuss a settlement. Over the next few days, I should receive an update from the attorneys about that development. As always, I will keep the community updated as the situation progresses.
- Councilman Werner has been in contact with Robert Balkind, the Dutchess County Commissioner of Public Works regarding safety along Salt Point Turnpike in the hamlet of Clinton Corners. This has been an ongoing topic of discussion between the Town Government and residents, and we are all aware of the dangers posed by vehicles traveling at unsafe speeds along this stretch of road. Just like past conversations, we have been told that the posted speed limit will not be lowered, and "recent crash data didn't reveal anything significant." According to the NYS Dept. of Health, injuries to pedestrians are among the top 10 leading causes of injury-related hospital admissions and death for almost all age groups In New York State. I, we, are urging everyone to please take it slow through the various hamlets in Town, and do not endanger the lives of our neighbors.
- Rebuilding Together Dutchess County is a leading non-profit working to preserve affordable home ownership by providing no-cost home repairs and modifications to income qualified homeowners. Applications for home repair and renovation services through the Rebuilding Day program are now available in the Town Clerks office, on our town website at townofclinton.com, or online at rebuildingtoghetherdutchess.org. Applications will be accepted through August 31.
- Finally, the Town of Clinton Recreation Department is ramping up for a busy summer, and I wanted to highlight some of the activities they have planned.
