## RESOLUTION APPROVING STIPULATION OF DISCONTINUANCE (INDEX. NO. 2023-51981).

**WHEREAS**, Katerina Maxianova, Edward Wilson and Wendie Adelman (the "Petitioners") commenced a special proceeding by petition in Dutchess County Supreme Court (the "Court") bearing Index. No. 2023-51981 (the "Article 78 Proceeding") against the Town of Clinton and the Town of Clinton Town Board (collectively, the "Town") and Medical Arts Sanitarium Inc et. al. (collectively "Cornerstone"); and

**WHEREAS**, The Petitioner's and Cornerstone have entered into a Stipulation of Settlement which has been filed with the Court; and

**WHEREAS**, The Town is not a party to the Stipulation of Settlement; and

**WHEREAS**, The Petitioners, the Town and Cornerstone desire to discontinue the Article 78 Proceeding with prejudice pursuant the Stipulation of Discontinuance, a copy of which is attached hereto and made a part hereof; and

**WHEREAS**, Cornerstone will hold said Stipulation of Discontinuance in escrow pending the completion of the proceedings before the Planning Board regarding Cornerstone's application for an increase in patient capacity; and

**WHEREAS**, the Town Board now desires to approve the Stipulation of Discontinuance and authorize, direct and empower Shane J. Egan, Esq. to execute the Stipulation of Discontinuance on behalf of the Town and take any further actions necessary to effectuate the terms of the Stipulation of Discontinuance.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board hereby authorizes, directs and empowers Shane J. Egan, Esq. to execute the Stipulation of Discontinuance on behalf of the Town and take any actions necessary to effectuate the terms of the Stipulation of Discontinuance.
