## RESOLUTION NO. 24 of 2023 AUTHORIZING THE ADOPTION BY THE TOWN BOARD OF THE TOWN OF CLINTON, NEW YORK OF LOCAL LAW NO. 3 OF 2023 entitled

## "Local Law Amending Article VII of Chapter 210 of the Town Code – Property Tax Exemption for Volunteer Firefighters and Ambulance Workers"

**WHEREAS**, on March 21, 2023 a resolution was duly adopted by the Town Board of the Town of Clinton, New York authorizing a public hearing to be held by the Town Board on April 11, 2023, at 6:25 p.m., at the Town of Clinton Town Hall at 1215 Centre Rd, Rhinebeck (Town of Clinton), New York, to hear all interested parties on a proposed Local Law entitled "Local Law Amending Article VII of Chapter 210 of the Town Code – Property Tax Exemption for Volunteer Firefighters and Ambulance Workers"; and

**WHEREAS**, the Town Board having determined that all parties entitled to notice have been duly given notice thereof; and

**WHEREAS**, pursuant to 6 NYCRR Part 617 of the implementing regulations pertaining to Article 8 State Environmental Quality Review Act (SEQRA) the Town Board hereby determines that adoption of this proposed Local Law is a Type II action which would not have a significant effect upon the environment; and

**WHEREAS**, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law.

**Now, Therefore Be It Resolved**, that the Town Board hereby adopts said Local Law No. 3 of 2023, entitled "Local Law Amending Article VII of Chapter 210 of the Town Code – Property Tax Exemption for Volunteer Firefighters and Ambulance Workers" a copy of which is attached hereto and made a part of this resolution; and

**Be It Further Resolved**, that the Town Clerk be and she hereby is directed to enter this Local Law in the minutes of this meeting and give due notice of the adoption of this Local Law to the Secretary of the State of New York.
