RESOLUTION APPROVING BOND AND AUTHORIZING THE TOWN SUPERVISOR TO EXECUTE SECURITY AGREEMENT WITH DUTCHESS RESERVE LLC FOR COMMON DRIVEWAY IMPROVEMENTS

WHEREAS, Dutchess Reserve LLC has received approval for Sections 1 and 2 of a phased subdivision from the Town of Clinton Planning Board to create a 5-lot subdivision on an 110.957-acre parcel, (Parcel Id. No.: 132400-6568-00-017281-0000), located on Pumpkin Lane pursuant to Planning Board Resolutions dated September 3, 2024;

WHEREAS, Section 2 of the phased subdivision includes a common driveway and related improvements which will be constructed;

WHEREAS, to ensure the restoration of the area surrounding the proposed common driveway and related improvements should Dutchess Reserve LLC default the Town Engineer has recommended a bond in the amount of \$25,000.00;

WHEREAS, a copy of the bond and security agreement with exhibits, are attached hereto and made a part hereof;

WHEREAS, the Attorney to the Town and the Town Engineer have reviewed and approved the bond and security agreement; and

WHEREAS, the Town Board is required to approve the bond and security agreement.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board approves the bond in the amount of \$25,000.00; and

BE IT FURTHER RESOLVED, that the Town Supervisor is authorized, directed and empowered to execute the attached security agreement and to take any and all actions necessary to implement the provisions of this resolution.
