RESOLUTION AUTHORIZING THE ADOPTION BY THE TOWN BOARD OF THE TOWN OF CLINTON, NEW YORK OF LOCAL LAW NO. 31 OF 2022 entitled

"Local Law Increasing Income Eligibility for Senior Citizen Tax Exemption"

WHEREAS, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law.
