### RESOLUTION No. 43 of 2021

#### INTRODUCTION

Local Law No. \_\_\_\_\_ of 2021

The following proposed local law, to be known as Local Law No. \_\_\_\_\_ of 2021 of the Town of Clinton, entitled "Local Law Prohibiting On-Site Cannabis Consumption Sites", a copy of which is attached hereto and made part hereof, is hereby introduced.

WHEREAS, the Town Board of the Town of Clinton (the "Town Board") has determined that a local law prohibiting the establishment of on-site cannabis (marijuana) consumption sites commonly known as smoking parlors in the Town of Clinton (the "Town") is necessary and in the best interest of the Town in order to protect the health, safety and welfare of its' citizens; and

WHEREAS, the action to adopt this proposed Local Law is a Type II Action under the New York State Environmental Quality Review Act regulations for which no environmental review is required;

WHEREAS, this proposed Local Law is adopted pursuant to NY Cannabis Law § 131 which authorizes and empowers the Town Board to adopt a local law requesting the New York State Cannabis Control Board prohibit the establishment of on-site cannabis consumption licenses within the jurisdiction of the Town;

WHEREAS, this proposed Local Law is subject to a permissive referendum pursuant to § 24 of the Municipal Home Rule Law; and

BE IT FURTHER RESOLVED, that a public hearing be held in relation to the proposed Local Law as set forth in the form of notice, hereinafter provided, at which hearing parties in interest and citizens shall have an opportunity to be heard, to be held at the Town Hall on October 12, 2021, at 6:15 o'clock p.m., Prevailing Time, and that notice of said meeting shall be published in the official newspaper of general circulation in the Town by the Town Clerk, at least five (5) days before such hearing and that such notice shall be in the following form:
