# **Information for 2021 Annual Report**

## Projects/Work Completed or Ongoing from 2021:

### Part 1: Clinton CAC

- Ten meetings were held.
- Reviewed seven Planning Board applications. There is an increase in large properties being subdivided, mostly
  into two lots with the intention to sell as buildable lots.
- Pollinator Pathway Project overwhelmingly approved by the Clinton Town Board at the May 11, 2021 board meeting after CAC member, Maya Goer-Palenzuela, gave her introduction to the project.
- Created "Town of Clinton of Dutchess County" page on the Pollinator Pathway website. Members added their locations to the Dutchess map. Frances J. Mark Memorial Park and Omega Institute have also been added.
- Introduced the Pollinator Pathway in a Zoom meeting with the Friendship Garden Club of Clinton.
- Keeping links of Pollinator Pathway Zoom meetings to serve as background information for residents who are
  interested in learning more. For example, 3-23-21 Town of Poughkeepsie CAC Pollinator Pathway "It Takes A
  Town" by Susan Hecht via Zoom; 11-3-21 What's the Buzz: Creating Pollinator Friendly Communities The
  CCEDC Environment & Energy Team hosted a fall 2021 environmental forum on the topic of creating pollinator
  friendly communities.
- Education Outreach
  - o Pollinator Pathway table at Clinton Community Library's Book Sale in June.
  - o Pollinator Pathway and Climate Smart Program table at the Democratic Committee Social in September.
- New *Friends of the Clinton Community Library* totes were developed. CAC-created environmental informational sheets are included. These sheets can be found on the CAC webpage Clinton's website.
- A bird walk was held at the Clinton Nature Trail in May.

#### **Part 2: Climate Smart Task Force**

- NYSERDA designated the town of Clinton as a Clean Energy Community on April 15, 2021. A CSC Task Force was
  established thanks to efforts of by Michael Whitton, then town board member. The first Climate Smart Task
  Force was held Tuesday, May 25th at 7pm. Ten residents of various backgrounds were invited to attend. CAC
  members, Jean McAvoy, Jacob Straus and Joe Phelan (Chair) are on the task force.
- The Town Board approved the continuation of the Community Choice Aggregation (CCA) program.
- The Highway Department is investigating the possibility of future purchase of electric vehicles.
- The town will be developing a Road-Stream Crossing (culverts & bridges) Inventory and Management Plan under the leadership of Sean Carroll at Cornell Cooperative Extension of Dutchess County (CCEDC)
- A Green Fair will be planned for the Spring.
- Benchmarking the town's energy consumption is ongoing.
- The town will take advantage of the Climate Smart Resiliency Planning Tool.
- The towns of Pleasant Valley and Hyde Park invited Clinton in collaboration on Repair Cafes.

- Eight CAC members!

- Maya Goer-Palenzuela will present her proposed "Pollinator Pathway Management Guidelines" concerning mowing in Clinton's parks and along its roads to the town board for approval.

- Working with the Planning Board, Building Department, and Zoning Board of Appeals in an advisory capacity on subdivisions, site plans, special use permits, community planning and development, and wise use of the town's natural resources.
- Working with the Summer Camp Director to provide environmental programs.
- Updating CAC information on the town website.
- Placing newcomer folders with the Town and environmental information in the offices of the Town Clerk.
- Walks in the Clinton Nature Trail and update the trail's kiosk with recent projects.
