## Projects/Work Completed or Ongoing from 2022:

## **Planning Board Applications -**

- Reviewed 4 Planning Board Applications. Currently, there is a 100acre parcel where a developer wants to build homes. The initial plan was for 12 houses, but the Planning Board is working to make that 5. The CAC has a good relationship with the Planning Board, and we will be asked to review the proposed plan when available.
- 5 members attended the Online Mapping Tools for Local Conservation Planning training in September. The mapping tools were shared with the Planning Board and ZEO officer.

## **Pollinator Pathway Projects:**

- CAC member developed 3 Pollinator Pathway presentations at the Clinton Community Library
  - 1. "Pollinators: Who/What Are They & Why Do They Matter?"
  - 2. "Best Native Plant Choices For Our Eco-Region for Threatened Pollinator Survival;"
  - 3. "Property Management: Nurturing Habitat for Non-Humans"
- Education Outreach Events: CSC Task Force's Green Fair, Clinton Community Library's Book and Plant Sale, and Clinton Community Day.
- CAC members developed handouts such as "No Mow May" and "To Mow or Not to Mow" on best mowing guidelines for events the CAC attended.
- Webpage on the Pollinator Pathway website called "Town of Clinton of Dutchess County"
- Sponsored two Master Gardener programs at the Clinton Community Library:
  - 1. "Stop the Spread: Scout for New Invasives Citizen Science Training"
  - 2. "Controlling Invasives in Managed Landscapes and Beyond"
- Planted a Pollinator Pathway Garden at the Clinton Town Hall Complex

## **Clinton Summer Camp Programs:**

- "I Bird New York Beginners' Birders Challenge"
- Monarch Butterfly exhibit. The campers took home caterpillars in homemade boxes to watch their development.
