Big EMS Win for Towns

The biggest news out of the past week or so was the NYS Senate passing S1515, which exempts emergency medical services (EMS) from the real property tax cap — a top priority for NYAOT. Stay tuned for full details as this legislation awaits the governor's signature.

Executive Director Chris Koetzle praised the move, saying:

"This legislative session, NYAOT made our priorities clear: strengthening emergency medical services (EMS) and reforming the property tax cap to better reflect the realities facing local governments. We advocated tirelessly for legislation that safeguards both first responder services and taxpayers, and we're proud to share that our efforts paid off.

Both the Senate and Assembly passed legislation to exempt EMS from the property tax cap, a significant step forward for towns struggling with the escalating costs of providing critical services. This exemption would give local governments the flexibility needed to invest in life-saving EMS without being penalized by arbitrary fiscal constraints.

NYAOT extends its sincere thanks to Senate and Assembly leadership, bill sponsors Senator Rachel May and Assemblymember Donna Lupardo, and to our members whose advocacy helped move this legislation forward.

We now urge the governor to sign the bill into law and give towns the tools they need to protect public health and safety."

ARPA Reporting Deadline Approaching

Don't forget: ARPA reports are due June 30, 2025. The Treasury Department has said it will begin seeking recoupment of funds starting July 2025 for noncompliance.

If you're still experiencing issues with the Treasury's reporting portal—even after contacting them—NYAOT strongly suggests the town keep detailed records of every attempt and reach out to your federal representatives. Documentation is your best defense.
