To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2024 and ending December 31, 2028;

To elect one (1) Fire District Commissioner for the four (4) year balance of an unexpired term commencing January 1, 2024 and ending December 31, 2027; and

To vote upon the following proposition:

SHALL the bond resolution of West Clinton Fire District, in the Town of Hyde Park and the Town of Clinton, Dutchess County, New York, entitled: "BOND RESOLUTION OF THE WEST CLINTON FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWN OF HYDE PARK AND THE TOWN OF CLINTON (COLLECTIVELY "TOWN"), DUTCHESS COUNTY, NEW YORK, ADOPTED NOVEMBER 8, 2023, AUTHORIZING CONSTRUCTION OF VARIOUS IMPROVEMENTS TO FIRE STATION #2, SUBSTANTIALLY AS DESCRIBED IN THE PLAN PREPARED FOR THE FIRE DISTRICT WITH THE ASSISTANCE OF LISCUM MCCORMACK VANVOORHIS, LLP, INCLUDING ORIGINAL FURNISHINGS, EQUIPMENT, MACHINERY, APPARATUS AND ANCILLARY OR RELATED SITE, DEMOLITION AND CONNECTION THEREWITH REQUIRED **OTHER** WORK IN (HEREINAFTER SOMETIMES CALLED "PROJECT"); STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$1,500,000, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND TO **AMOUNT** APPROPRIATING SAID THEREOF; FINANCING THE THEREFOR, INCLUDING THE EXPENDITURE OF \$500,000 FROM THE EXISTING "CAPITAL RESERVE FUND WEST CLINTON FIRE DISTRICT" APPROVED; WHICH IS HEREBY ESTABLISHED, HERETOFORE AUTHORIZING THE ISSUANCE OF BONDS IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$1,000,000, TO FINANCE THE BALANCE OF SAID APPROPRIATION; AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE," BE APPROVED?"
